The USA was founded on the principles of the Renaissance and Reformation where average people were sovereign, and the government was meant to be the servant of the people. The very constructs of USA and the Constitution give American-People sovereignty and politicians subordinate to American society. The silent majority reluctant to acknowledge (Bandwagon-effect) both political partisan-corruption and crime-against-humanity; no person can sit idly while their neighbor is assaulted. "USA Department of Treasury control over the production and distribution of money and credit for the country monetary policy. Deposit-taking and transaction services will be a public service to regulate it as a public utility."

"The value of the note equivalent to a bank loan only. Separation of banking and finance will be enforce."

"USA money-note right for printing will be USA Congress only in perpetuity to instruct the USA Department of Treasury."

"Base in the Law of the Land (metallic-currency) never under no circumstances the Law of the Sea can be apply to the country economy."

**"The USA money-note will never be peg to a foreign country assets neither protection from our military."**

"There should be no student loans from the Federal government neither federal funding to Universities."

"There will be no banking or investment of a foreign country or foreign individual all capitalism will be only to USA citizens."

"The mortgage market and the auto industry will be nationalized under the USA Department of Treasury cementing the economy and to Secure American citizens jobs."

"The child support will be nationalized under the Social Security Administration."

"Is prohibited the exporting jobs of banking and medical transcriptions, all businesses and personal documentation are USA base only."

"There should be no foreign aid without no exception."

"The USA Postal Service will be funded at all times to secure the average American citizens' communication among all states, jurisdictions, and the eradication is an absolute prohibition."

"USA renounce perpetual warfare is not consistent with American values and interest."

"War crimes, crimes against humanity, and incommunicado are prohibited, by American-People as a public policy in Perpetuity."

**"The USA Constitution restrictive force in wartime."**

**"USA Armed Forces' dishonorable-discharge apply only to crime-against-humanity, war-crimes, rape."**

The forensic image of the Dominion System discovered evidence of internet communications to public and private IP addresses. The Lenberg report indicates that vote modification in Antrim County was consistent with technical manipulation of the project file. Antrim County had no ballot rejections based on signature mismatch (Dec 17, 2020), and wrongly exercised their legislatively delegated authority when they issued a rule and ordered election officials to presume that a signature on an absent voter ballot is genuine (violation of the Administrative Procedures Act) without verify the legality-of-the-vote. There are over 66,000 ballots recorded that are not associated with a registered voter. Properly cast votes diluted or voided out by the counting of an illegal vote. Ballot Marking Device (BMD) with the Dominion voting machines undermines election integrity.

The Vote Review Panel determines voter-intent.

Ballots got jammed in the scanner and scanning-error-occurs; therefore, election workers discard the whole batch of scans and scan the ballots again. The ballot paper (historical-artifact-code) can detect if any code-changed (kinematic-artifact).

Mechanically "out of alignment" intentionally forcing adjudication?

Why do not State officials allow forensic examination of ballots?

Bill to separate Federal Elections at different day of States Elections. The only accurate way protecting-ballot-access is through ‘VOTER ID’ that secure Election Integrity, period.

- Twenty-four (24) hours before the election an official country registered voters list made accessible to the public as transparency versus votes.

- Provide all-ballots with a watermark (like birth certificate) and unique identification.
- Only the voter drivers’ license district when the voter has multiple residences.

Attempting to get the law-overturned will grossly infringed the woman "person-domain" (human-right), such aggression because morally-convictions (belief) in others free-will. People against abortions, shame woman who takes part in the practice. Governing her womb (inner-sanctum) is an overreach-of-authority. The nature of the issue involved, and the remedy sought cannot permit this revulsion intrusion of her body autonomy that prevails over

Moreover, women understanding that, if they-need-it, will be available to them; regardless, if the woman would live to regret her choice or not (immature-misjudgment). Adults are entitled to make judgements for themselves, autonomy & equality. Restricting abortions is unconstitutional sex discrimination because non-affluent women disadvantageous treatment that it treats other temporary disabilities affecting people; equality, right to choose. Also, interference violation on her right to privacy (Due-Process-Clause of the Fourteenth Amendment).

***Women suffer from detrimental effects of unsanitary operations, NO MORE. American-People declares and orders public health obligation (human-right) to perform safe-abortion equally as any emergency in-patient medical health services, such as rape, incest, miscarriage, woman's health (probable death) and mental health crisis. Any other reason should be surgery appointment.***

***Women in mental health crisis of unwanted child can turn into infanticide (mens-rea) or negligence-caregiver. Children from disadvantaged backgrounds have high possibilities to engage in delinquency, A FACT. Abortion cannot be the main method of birth control. Another alternative could be adoption, a safeguard to prevent maternal depression, due to insecurities and concerns (quality of life-as-you-live) that can cause regret about abortion as the improvement of the standard of living.***

94. **Prostitution** as a legal sex industry is a pernicious form of violence against women's body for sexual gratification or it is time to put aside moralistic prejudices. Indeed, the person selling sex will degrade (desensitized) by the violent criminal industry involving pimps and sex trafficking tied to gangs, drugs, and street violence. Inspected, this "black market" would not exist if licensed, medically inspected, and taxed (a trade of money for a service). Judging prostitution morality like "alcohol prohibition" in the past will fail since is a thriving illegal business just like drugs. Adultery is (morally) grounds for divorce but is not a crime. The "victimization" occurs when enter prostitution before they have reached the age of consent (rape) with a highly constrained choice or when client assaults the sex worker.

Criminalize the oldest "form of exploitation, trade, slavery and gender violence" originated by men to dominate women and keep them as their sexual dumping. In fact, history has shown that it has increased profitability by having sex trafficking more attractive to criminals.

Legislatures have wide discretion in regulating "immoral activities" within the police power of a State. The argument of legalization does not reduce violence because is part of the "working conditions" is debatable. As an example, Netherlands "tippelzone" reduces sexual abuse and rape. Moreover, long term decreases in drug-related crime. Sex work is an income-generating activity and demand for the sex trade is not inevitable. The International Labour Organization (ILO) estimates that sex worker support the family with their earnings, not only herself. Legalization is not meant for emancipation neither treat another person as a sexual object (violence against women) but has a choice between legal businesses, not an illegal criminal operation (performed under exploitative, unsafe, or unhealthy conditions). The reality is that social problems and mental health issues relate to prostitution (dangerous occupation) need intervention once for all.
