Viruses are excretions (exosomes) of a toxic cell trying to purify themselves, expose any biological system to electromagnetic field or pollutants.

Koch's postulates (**degree of certainty**) of germ theory (**immunity**) explain an agent of a microorganism outside the body invades and causes disease. **Isolating the infection agent out of the patient and give it to a healthy person or animal cause the same disease (method was unsuccessful with viruses)**. Scientists insisting on adhering to Koch's postulates failed to grow viruses by bacteriological techniques. Thomas Rivers (**modification of Koch's postulates**) statement about the **essential nature of viruses needs living cells to replicate**; nor, had any viruses been found multiplying free in nature. The problem of growing viruses in the laboratory (isolate and cultivate the virus in a cell-free medium) led to his conclusion. **Immunity to viral diseases is the fact that only active virus protects against a second inoculation of the same virus (Filterable Virus, Thomas Rivers)**. The prevention of diseases caused by viruses depends on the protection of the susceptible from exposure or upon their immunization. Quarantine measures are established for protection; nevertheless, frequently, they are ineffectual. All viruses are inactivated by high temperatures. No virus has been

obtained in an absolutely pure state. Virologists need to question: Why there is no control group (principle of the scientific method) in their experiments? Simon Flexner (director of the Rockefeller Institute) claimed to have isolated and cultivated the polio virus in a cell-free medium is questionable.

“Silent Spring” by Rachel Carson: insect-spray containing 50% DDT, harmless to humans at that time.

Separation of exosomes from viruses does not exist, because they are the same; is a ‘detoxification-strategy’ from the inside, from a ‘pathogenic virus from the outside.’ Those pieces of genetic material can resonate out into a signal, DNA and RNA has a resonance. If you expose a place to millimeters waves (5G): degrade the oxygen in the atmosphere, interferes with your mitochondria (tissue-hypoxic), cytokine-storm (hyper-inflammatory response). Dangerous to be injected with electroporation with electromagnetic frequencies.

United States Court of Appeals, District of Columbia Circuit: Environmental Health Trust v. Federal Communications Commission and United States of America (AUG 2021):

“...Commission’s RF radiation limits continue to be based on thermal heating...out of date and inapplicable today.”

FCC’s refusal to update 1996 regulations limits on allowable radiofrequency radiation (RF) exposures from wireless technologies. Outdated knowledge that heating is the only proven harm from RF. New data, documenting biological effects and illness from wireless radiation exposure below heating levels. FCC compliance does not ensure safety, dismissal of harm deemed insufficient, failed to evaluate the numerous health effects documented in scientific studies. Children were more vulnerable to wireless; developing brains are more sensitive, absorb higher levels of RF deeper into their brains. Also, substantive evidence of potential environmental harms.

American-People have to hold accountable the FCC officials if their current policy of the mandatory irradiation of the public has potential harmful health impact. The agency needs to provide their studies to assure there is no harm from radio frequency radiation when the Internet of Things (**5GENESIS**) go live. In addition, **Joint Enterprise Defense Infrastructure (JEDI)** in conjunction with satellites. The **Jedi Cloud** will always be on private sector, and this is a national security breach; Do American-People have the capacity to achieve and overall, this task? Dependence (“deep capture”) on the Military-Industrial Complex for the country defense is a dangerous and economic detriment.

Electrical currents exist in the human body due to the chemical reactions that occur as part of the normal bodily functions (keeps our bodies alive). Low-frequency magnetic fields induce circulating currents within the human body. These bio-magnetic fields interact with all of the other magnetic fields on the planet. Neurons’ fire (electrical-signals) to carry-out cognitive tasks (thoughts or body’s movement) that can be aligned to neural-frequencies. The importance of inter-brain neural synchronization for the study of consciousness. Brain-to-brain synchronization during cooperative social-interaction, this phenomenon, an emergent property of social-dynamics. Conscious experience in the world is the adjustment of ongoing neural-rhythms to external-stimuli (amplify or reduce neuronal responses to events of an information stream). Greater inter-brain oscillatory synchronization is associated with enhanced performance and can predict team efficiency. Synchronization occurs when two oscillators reciprocally adjust their ongoing rhythms due to cooperation and one-all (hyper-connectivity). Human consciousness requires mechanisms occurring within the brain, but neural activity is also interaction with other people and the world, qualitative sense of sharing an experience together. Consciousness is difficult to investigate scientifically. ‘Telepathic-electronic two-way communication;’ speaking through telepathy using extreme-low-frequency (ELF-thought projection)?

Einstein’s ‘photoelectric-effect’ (quantum-nature-of-matter) lead to Quantum Mechanics (world of tiny particles governed by randomness). Einstein dismissed the ability of separated objects to share a condition or state and believed underlying laws of nature that defines particles (speed & position). Quantum Entanglement (QE): apart in space, their states remain linked. QE-EPR Paradox: paradoxical effects; changes the original quantum state with entangled particles, then, as whole. Consciousness as quantum wave of light, and photons as particle.

Bohr: measurements of position and momentum are complementary.

Many-Worlds-Interpretation of QE: unitary part without collapse but multiple outcomes, local and deterministic.

Principle of local realism.

Free-Will Theorem: ‘elementary-particles;’ John H. Conway & Simon B. Kochen.

Photon –particle of electromagnetic radiation (EMR), are waves of electromagnetic (EM) field propagating through space. Linearly polarized sinusoidal electromagnetic wave: synchronized oscillations of electric and magnetic fields.

Electromagnetic Spectrum: frequency of oscillation/wavelength. EM –near-field waves (Homo-sapiens) carry energy, momentum/angular momentum; impart those quantities to

interacting-matter, away from source particle. EMR –far-field-waves (YHWH), electromagnetic radiation without affects them, causes them to be independent in the sense of their existence and their energy. Completely independent of both transmitter and receiver (autonomy & free-will); researchable only by universal-consciousness (wave of light), faster than laser. Biometric resonance/entrainment frequencies coupling external electromagnetic fields.

EM radiation power-density fade with distance but EMR's conservation of energy. The electromagnetic fields of light traveling in linear medium do not get affected by vacuum but crystals (non-linear medium) interactions between light and static electric and magnetic fields occur (tensor).

Interference: superposition of more than two waves resulting new wave pattern (reality); fields same directions constructively interfere but opposite directions cause destructive interference.

De-coherence: environment cause quantum behavior to decay; can be reverse with Homo-sapiens' consciousness-superposition into EMR's Hologram, need exploration.

HUMAN BEINGS ARE FREQUENCIES.

Melatonin: hormone made in the brain, powerful antioxidant secretes only at night (darkness) when the brain repairs the cells of our body, **Schuman Resonance (7.83Hz Earth Frequency**-origin of life) which Human Race has evolved is the same as Human Alpha Waves (7.83Hz **Brain Frequency**-immune system). Human body cells communicate using electromagnetic frequencies, the brain emits frequencies, and our DNA delivers the fights free radicals, regulates sleep cycles, among others. The brain cannot distinguish between natural light (visible light-frequency) and man-made electromagnetic fields.

Cryptochromes (human sensitive magnetic field) absorb blue light, exposure to **electromagnetic low frequency (ELF)** induce pineal gland suppressing the synthesis of Melatonin affecting human body cells; also, affecting the immune system (prompt to disease), sleep disorders and heart complications.

Effects on human circadian rhythms sensitive indicators influence of **ELF**. Electromagnetic Radiation environmental pollution (lack of harmonic) threat of extinction of bees and birds. The bee colonies began collapsing, that is, around 70% of the World's Food crops pollinated by bees. Disruption of Earth's magnetic fields affects the bird's navigation.

World Health Organization (WHO) acknowledges **electro sensitivity** (body reacts to electromagnetic fields) can be severe and disable. Radiofrequency electromagnetic fields carcinogenic to humans and increased risk of brain tumor.

Borax/Boron-Nanofilament Replication Inhibitor, Chemtrails-Morgellons-nanobots crystal filaments. Also, detoxifies liver, absorption of minerals, hormones balance, improves cell

function, regulates candida, and detoxes fluoride. Borax/Boron-2 tablespoons per day (1/4-200 lbs. and 1/8- 100 lbs.) plus Organic Apple Cider/MotherRaw.

COVID-19-hypoxemia main characteristic is the dissociation between the severity of the hypoxemia and the maintenance of good respiratory mechanics. Two types of patients (non-ARDS and ARDS) with different pathophysiology distinguishable by CT scan. Chest CT is a fast way of beginning diagnosis of SARS-CoV-2 infection finding abnormalities in the lungs such as centrilobular nodules, bronchial wall thickening, vascular enlargement, traction bronchiectasis, architectural distortion, among others.

Polymerase Chain Reaction, PCR-based technique used to detect pathogenic viruses in blood and respiratory secretions. The RT-PCR recommended for coronavirus. Two negative PCR tests taken 24 hours apart are a better indication of being infection free. The absence of monoclonal antibodies to the novel Coronavirus, how can a pathologist verify Covid-19 is present in the body?

“One of the most troubling aspects of the Pseudo-Epidemic is that all the decisions seemed so sensible at the time.” Dr. Elizabeth Talbot.

The PCR test used to diagnose Covid-19 does not fit as an effective diagnosis of infection, way too many false positives, ***“[...] never designed to diagnose diseases.” Professor Kary B. Mullis, PCR test inventor.***

RT-PCR technique used as an intentional strategy by governments to justify excessive measures such as violation of constitutional rights. Chinese cities using anal swabs to screen Covid-19 infections because virus traces in fecal matter remain detectable and accurate test results.

Richard A. Rothschild filed for a provisional patent on “System and Method for Testing for Covid-19 on October 13, 2015, revealed the Dutch Government patent registry website; (publicatie: US 2020279585 (A1), 2020,09-03). Does U.S.A. have Covid-19 medical treatment since the beginning of “Gate Pandemic”?

Individuals that lack specific interferons (IFNs) can be more susceptible to infectious diseases. Also, neutralizing auto-antibodies (auto-Abs) against type 1 IFNs may underlie critical Covid-19. Covid-19 infected patients can be screened to identify individuals with auto-Abs at risk of developing life-threatening pneumonia. Preventive or therapeutic intervention includes plasmapheresis, monoclonal antibodies depleting plasma blasts, and the specific inhibition of type 1 IFN-reactive B cells, autoimmune-disease?

The difference between a cold (respiratory syncytial virus, rhinovirus among other viruses), a bad case of influenza (pneumonia), and Covid-19 dangerous symptoms: anosmia (lose sense of smell), serious breathing difficulty, blue lips or face, confusion, incoherence, collapsing or

losing consciousness get immediate attention. Serious symptoms of Covid-19 are the swelling of the brain (encephalitis). EEG (electrical activity) scans showed abnormalities in brain activity. MRI or CT scans (brain imaging) to look at the frontal lobe. Wuhan Institute of Virology, Wuhan-400 virus can engulf the brain tissues leading to loss of control (bodily function) in patient's body. Another one, H5N1 Hybrid viruses. Multisystem inflammatory syndrome can cause organ failure. Visibility threshold (limit of what the naked eye can see) 10-40 μm , bacterium 1-3 μm , and Covid-19 0.1-0.5 μm ; which corporations have this technology?

EXAMPLE: New York City Housing Authority (NYCHA): HPD, DOB, ECB violations, NYC eviction facing homelessness (pandemic-wealth-transfer), Also, onboard, Chancellor David Banks’ remote option (Telecommuter-Agenda2030), blatantly Human Rights violations against low-income-families’ students (intellectual-wealth-inequity), residents’ quality-life and safety are not priority, only their vote (indignation). American-People, this despotism cannot solve problems neither grievance by not talking about it, need-scrutiny. DO NOT CONFORM TO LEFT/RIGHT FACISM, MEDICAL-TYRANNY.

EXAMPLE: FUTURE; DARPA 3D-printed-mixed-waste serve as traditional-food (DYSTOPIA); ENGINEERED SHORTAGE, FAMINE.

SCIENTISM –science is the only source of human knowledge. Reject or accept non-scientific sources of belief, such extra-scientific assumptions have any effect on actual scientific practice? Common-sense needs to have some epistemic-worth, for it to serve science. Science emphasizes high epistemic-quality, that the given ‘source-of-belief’ can be checked for errors and biases (epistemically evaluated in ‘terms-of-reliability’); why such non-evaluable sources are necessary for doing science? Non-evaluable sources like pure intuitions or divine revelations have no means to determine reliability. Explicit-criterion, the ‘epistemic evaluability-of-reliability’ for determining the accepted sources is not arbitrary. Science does not need to rest on non-scientific sources to be justified. Scientism as a ‘scientific hypothesis,’ justify it by scientific means. Science is not limited to the natural

sciences but encompasses social sciences. General rules-of-inference are applied in all descriptive-research (explicit-for-evaluation) to improve the reliability of the study. Scientism in healthcare, understanding of the disease as the only relevant issue ignoring other factors. SCIENCE –THE DATA COLLECTED BY SCIENTISTS ARE OPEN TO TESTING BY OTHERS.

Is Covid-19 a retrovirus? “Reactivated” rather than a patient's resurgence of the disease (lurking in the immune system) means, there are different virus strains (genetic code). Hong Kong scientists confirmed Covid-19 reinfection. The acute respiratory distress syndrome (respiratory failure) treated with a ventilator, will increase pressure on the lungs, causing injury. **COVID-19 lack oxygen** (cellular oxygen deprivation), correlation with 5G-60 GHZ (frequency oxygen molecules oscillate) with similar respiratory illness symptoms of **HYPOXEMIA** (low oxygen in your blood) and this can cause **HYPOXIA** (low oxygen in your tissues to meet body needs). Can 5G-Technology cause induction of coronavirus in skin cells? There is no evidence 5G causes or exacerbates the spread of COVID-19. Human Virus cannot spread via radio signals. Covid-19 and SARS-CoV-2 are fundamentally different (have the virus without the disease). Vaccinated people are protected against Covid-19 but still spread SARS-CoV-2 to others. There will never be a sterilizing immunity that completely prevent infection but surely there will be a new infection after another.

Bill to enforce inoculation trial-endpoint only on the virus that causes the infection.

Future outbreaks of viruses and pathogens will continue besides the threat from antibiotic-resistant bacteria, a solution has to be sought. Disease prevention as measures to avert the occurrence of disease and reduce its consequences. **Professor Roger Seheult**, MD explains the important role Vitamin D may have in the prevention and treatment of Covid-19 (medcram.com). Vitamin D 2,000 IU., daily to strength innate immune system or health adaptive immune response where the body begins to make antibodies. Vitamin D- lower the risk of viral respiratory, track infections. The soft gel form of Vitamin D (oil soluble) is more bio-available after ingestion, monitored the blood levels to increase doses. Vitamin C- immune defense by supporting various cellular functions of the body's immune systems, prevent respiratory and systemic infections. Zinc prevents the RNA-transcription of Coronavirus.

Quadruple Therapy (Manikappa, 2020) involving four medicines as a preventive, and as a treating method repeated every 14 days: **Ivermectin** 12mg one dose (FLCCC Alliance), **Doxycycline** 100mg once a day for four days, **Zinc** 50 mg once a day for four days and **Vitamin D3** once a week. Prevent viral multiplication and entering human cells; **Ivermectin, combination prophylaxis halt coronavirus infection? The adenovirus vaccine (tablet) protects the host from respiratory infection, develop neutralizing antibodies.** Does antibody 47D11 neutralize SARS-CoV and SARS-CoV-2? **Griffithsin drug, inhibit protein S**

activity? Japan used **Favipiravir** (antiviral medication) to treat influenza; in 2019 became a **generic drug**. Also, used by India for the treatment of Covid-19 (Fabi Flu). What about **Tamiflu** (Oseltamivir phosphate)?

“Should consider Tamiflu as a prophylactic measure.” Dr. Nicole Lurie.

SARS-CoV-2 is a single-stranded RNA-enveloped virus. Two functional characteristics anion channel and a PDZ-binding motif (PBM) conserved in the core gene, stimulate a cytokine storm? **Hexamethylenemiloride** (acting on ion channels) and **SB203580** (effect on PBM) impair this mechanism. Also, **SARS E protein inhibitors** are suggested (Alam, 2020). SARS-CoV-2 sequencing has papain-like protease/deubiquitin domain, a unique protein in nsp3 promising viral inhibitor. **Disulfiram** (inhibitor nsp3) and **Darunavir** (conformation changes PLZpro) cause change in the function of this protease and can be considered as treatment options (Zhou, 2015; Hoffmann, 2020; Lin, 2020). What enzymes can remove glycans (sugar molecule) shield defense against antibodies (poised for infection)? Glycan-shielded viruses like influenza, coronavirus, HIV, and some cancers. Coronavirus spike protein binds the angiotensin converting enzyme 2 (ACE2) allowing viral infection on human cells. N-glycans link to the spike protein at sites N165 and N234 reduce binding to ACE2?

The nsp12 has two polymerase activities (RNA synthesis activities) using homopolymaric-RNA templates (Ahn, 2012). **Vitamin B12** (methylcobalamin) may bind to the active site of nsp12 and inhibit it; therefore, can be used as an antiviral drug in SARS-CoV-2 (Narayanan and Nair, 2020). **Favipiravir** inhibits the virus by targeting the catalytic domain of nsp12 (Furuta, 2017). This drug reduces the symptoms of the disease in people infected with the SARS-CoV-2 such as: **temperature normalization, respiratory rate, oxygen saturation (Al-Tawfiq, 2020)**. **Inhaled corticosteroid ciclesonide, nsp15 inhibition might be appropriate treatment SARS-CoV-2 (Matsuyama, 2020)**. Oxidative stress equal disease, does intravenous N-acetylcysteine (NAC) administration have beneficial effects reducing inflammation? Reduce C-reactive protein (CRP) which is a risk factor for Covid-19 disease progression? Is it beneficial for asthmatic patients? G6PDH deficient patients treated with **Hydroxychloroquine Sulfate (HCQ) 200 mg tablets-treats autoimmune diseases and NAC can block Hemolysis?** **Melatonin** increases G6PDH can be given to patients on a ventilator; increase survival? Can it reduce hemolysis (rupture of red blood cells)? According to research at the Cleveland Clinic the hormone Melatonin (regulates the sleep-wake cycle) could be used to possibly help prevent Covid-19. It also, reduces chronic and acute inflammation and help regulate the immune system.

“The advantage of drug repurposing is that the drug is already approved. It has already gone through regulatory process to show that it’s safe and effective for something. So, if you can find additional uses for that drug, you already know there is a good safety profile.”

“It’s just a matter of matching the right drug to the right disease.” Dr. David Fajgenbaum, Director of the Center for Cytokine Storm Treatment and Laboratory.

“They’re generic medicines, so there’s no patent on them...There’s no big pharmaceutical company behind that to push that forward.” Dr. David Boulware.

The practice of finding new uses for old medications (patents have expired)—advancing systematic drug repurposing for diseases without treatments. The CORONA Project—translational research involves finding out what goes wrong on the cellular level with the disease and analyze if any drug already treats the illness (basically testing different drugs in a petri dish with patients’ cells to assess outcomes). The timing of drug administration, for example, **Dexamethasone**, is harmful if it is given too early in the disease course. One important part is preventing infected patients from getting so ill needing to be hospitalized in the first place. Antivirals are unlikely to be effective so far into the disease course. **Fluvoxamine** (selective serotonin reuptake inhibitor-SSRI) decreases inflammation in the brain. It is a pill used to treat depression; costs \$12 a course of treatment.

Dr. Francis Collins, Director of the National Institutes of Health—Accelerating Covid-19 Therapeutic Interventions and Vaccines (public-private partnership) prioritize the repurposed drugs worth investigating.

Bill to create with unlimited funding Fajgenbaum-Boulware Repurposed Drugs Research Institute to assess various drugs given during different stages of a disease course and create a public, AI Database, accessible for peer-review without exceptions. Any medical equipment needed must be immediately purchased. All available medicines to present and new ones continuously repurposed. Private industry is prohibited any intervention. Fenbendazole –Canine Dewormer, cured terminal cancer?

Bill to open an investigation if criminal negligence was present in White House Advisor, Dr. Fauci’s Covid-19 assessment? Is the United States treating Covid-19 incorrectly? The decision to take any medications is between a patient and their doctor, not the FDA, a conflict of interest?

New Viral strains created by mixing bird-flu virus with human influenza could cause a global pandemic. This super infecting hybrid virus deemed to be most likely agents of bioterrorist attack. Russia (Dec 2020) reports first human cases of avian influenza A-H5N8 (pathogenic), future mutations can be transmitted person to person. H5N8 bird flu virus detected in Lithuanian poultry (Jan. 2021). Chimeric viruses are more pathogenic than the parent strain. Recombination occurs when two or more related viruses infect the same host cell and exchange sequences. The net result is a new variant derived from two parental genomes. Also, allows viruses to create novel genomes and to modify itself with mechanism that allow the exchange of sequences between RNA and DNA molecules. RNA-DNA hybrid virus possess

reverse transcriptase (enzyme) copy DNA or cDNA builds own strand. A unique chimeric virus (CHIV) genome emerged via recombination between ssRNA and ssDNA. The validity of the assembled viral genome confirmed by PCR amplification. The importance is their direct effect on the well-being of humans such global ecosystems (extreme geothermal, soil, freshwater among others). CHIVs are exclusively retrieved from aquatic and atmospheric environments. The 'viroisphere' uncover connections of unrelated viruses. Further, zoonotic transmissions of avian influenza-A viruses pose a threat to humans (H5N1 and H7N9). Also, bat's influenza viruses are hosts of threatening pathogens (Ebola, rabies, SARS-CoV and MERS-CoV). Bat chimeric viruses are resistant to Amantadine treatment, but inhibited with **Zanamivir** and **Ribavirin** (Juozapaitis, 2014).

The virus is real, the possibilities of "electro smog" infection, natural or "biological warfare;" but stop living (daily routine) is the worst decision-making end-result for average American citizens and 'Homo-sapiens-One-All.' The World Health organization (WHO) Influenza Laboratory Surveillance Information by the Global Influenza Surveillance and Response System (GISRS) stopped recording, why?

USA 2019-2020 Flu Season, 274,000+ P&I Deaths but Influenza Burden (CDC) 22, 800 (Flu View Interactive). 2020-2021 Flu Season, 385,000+ P&I Deaths and counting.

Medicare: \$13,000 (C-19 admission in hospitals), 39,000 (ventilators), 100-C-19 admissions, 75,000(hospital reimbursements) without a lab test.

Test Criteria-PCR Test threshold limit correct test to 29 cycles with Influenza A&B to avoid “testing-epidemic.” H1N1- “Cytokine storms”- Xoflusa, Baloxavir Marboxil, Oseltamivir antiviral medicines that shortens the symptoms.

The re-infection exposure does not carry the same risks of severe disease, will go down (even without a vaccine). DoD-Joint Artificial Intelligence Center (JAIC): data-analysis program, ‘Project-Salus’-Antibody-Dependent-Enhancement (ADE) accelerating among vaccinated (aged-65+). C19 hospitalizations also occurring among fully vaccinated-individuals and natural-immunity derived from previous COVID-19-infection are having better outcomes. “Those who won our independence believed...that public discussion is a political duty; and that this should be a fundamental principle of the American government...that fear breeds repression; that repression breeds hate; that hate menaces stable government; that the path of safety lies in the opportunity to discuss freely supposed grievances and proposed remedies...Recognizing the occasional tyrannies of government majorities, they amend the Constitution so that free speech and assembly should be guaranteed.” Justice Brandeis, Whitney v. California (274 US 357).

“The people, not the government, possess the absolute sovereignty.” MADISON.

The Right of the People to determine and resolve public issues. For a representative democracy ceases to exist the moment whenever their constituents can be restrained in any matter from speaking, writing, or publishing their opinions upon any public measure. We must ‘make an independent examination of the whole record,’ to assure the judgment does not constitute a forbidden intrusion of free expression (Edwards v. South Carolina (372 US 229)).

US Supreme Court coined the term ‘clear and present danger’ test to constitutionally limit an individual’s free speech rights under 1st Amendment (Schenck v. US (1919). Near v.

Minnesota (1931) protects citizen's freedom of speech from the federal government's censorship or punishment. Do not act with 'actual malice' but vigorous debate about government and public affairs (NYT v. Sullivan (376 US 254)). Authoritative interpretation of the 1st Amendment refused to recognize an exception for any test of truth, whether administered by judges, juries, or administrative officials and especially one that puts the burden of proving truth on the speaker (Speiser v. Randall (357 US 513)). The constitutional safeguard was to assure interchange of ideas for the bringing about of political and social changes desired by the people (Roth v. US (354 US 476)). The maintenance of the opportunity for free political discussion to the end that government may be responsive to the will of the people and that changes may be obtained by lawful means, an opportunity essential to the security of the Republic, is a fundamental principle of our constitutional system (Stromberg v. California (283 US 359)). The constitutional protection does not turn upon 'the truth, popularity or social utility of the ideas and beliefs which are offered.' These liberties are essential to enlightened opinion and right conduct on the part of the citizens of a democracy. Obsolete doctrine that the governed must not criticize their government, erroneous statement is inevitable in free debate. Discussion cannot be denied, and the right of criticism must not be stifled but robust and wide-open. It is the suppression of all criticism in reporting, 14 years in prison for violating –espionage and unauthorized-disclosures offenses in 'term-of-intent', protecting any wrongdoing of a politician.

Biden administration 'body-autonomy and privacy' intrusion denied dissent scientists have their research peer-review to achieve 'consensus' is by definition FASCISM. Example, to remove 'flagging' content for Facebook. Extended medical tyranny against 'USA Constitution and Declaration of Independence.' Incorrect form of government, 'White Supremacy' as NAZIS did. Polymerase theta was more efficient and introduced fewer errors when using an RNA template to write new DNA messages, than when duplicating DNA into DNA, suggesting that this function could be its primary purpose in the cell." "Like Pol theta, HIV reverse transcriptase acts as a DNA polymerase, but can also bind RNA and read RNA back into a DNA strand." "This work opens the door to many other studies that will help us understand the significance of having a mechanism for converting RNA messages into DNA in our own cells." Dr. Pomerantz

For example, this finding suggests that RNA messages can be used as templates for repairing or re-writing genomic DNA challenging central dogma in biology.

GO synthesis, and its physicochemical properties.” “They are used to administer drugs, proteins, genes, vaccines, polypeptides, and nucleic acids.” Rhazouani.

The problem of balancing therapeutic effects of GO and its ‘toxicity’ as biological safety of this nanoparticle. The ability of nanoparticles to penetrate the body’s tissues. GO, an excellent drug delivery system but potential health-risk and neurotoxic potential of GO are not yet clear. Studies have shown that GO is capable of inducing genotoxicity.

“Indeed, exposure to GO caused a significant decrease in neurotransmitters such as tyrosine, tryptophan, dopamine, tyramine, and GABA.”

“...small nanosheets of GO reduce glutamate availability, which is the major excitatory neurotransmitter in the Central Nervous System.” Rauti.

“...GO induced mutagenesis at the molecular level.” Liu.

“...Once GO penetrates the cell, it can destroy high amounts of lipid membrane degradation.”

Chronic Toxicological- peer-review is urgently needed as an ethical-science principle to humanity. The benefits and risks of GO for human health. Engineered nanomaterials higher production of ROS resulting in cytotoxicity and genotoxicity?

The writer humbly believes this nanoparticle is bound as the electrical current needed in human-body activity-surveillance.

Genetically engineered ‘magneto’ protein remotely controls brain and behavior. The method uses a magnetized protein that activates specific groups of nerve cells from distance. Optogenetics uses pulses of laser light into the brain and could manipulate memories. Chemogenetic induce biochemical reactions to activate nerve cells.

Transfection-technology to genetically modified organisms through electroporation (mechanical). The electroporation is the process of using an electric pulse to transfer cells with DNA. DNA-based nanocomposite hydrogel bioengineered smart-hydrogel synthetic DNA for self-assembling. Hydrogel nanotechnology-microscopic robots connecting to AI, Can also receive information? Where is the nanotoxicology and safety studies? Acrylamide (lethal neurotoxin), can it cause cancer? The transfected DNA enters the cell but does not integrate (transient) into the genome of the cell. There is an inherent risk of non-specific integration into the cellular genome. Also, integration of foreign DNA is usually rare (stable transfection). USA Supreme Court ruled (2013) that synthetic DNA or cDNA (edited version of the DNA that is injected into a cell to produce a specific protein) is patent eligible because “it does not occur naturally.” Therefore, if the company uses it on humans: **Are human beings considered Synthetic Biology property?** Trust any of them with your life?

GE-DARPA (March 2021) project leverages GE's expertise regarding novel synthetic method for producing industrial amounts of DNA using enzymes to make DNA synthetically instead of purifying it from living cells. **DARPA-NOW** (Nucleic Acids On-demand Worldwide) program created to develop a mobile medical manufacturing platform for DNA/RNA-based vaccines and therapeutics field-forward forces against bio-threat attacks and emerging infectious disease. **GE-RUN FAST** (Rapid Universal Nucleic Acids using Fieldable Automated Synthesis Technology) ability to produce ready-to-use vaccines in under 3 days at the site-of-need (deployment at an unprecedented speed).

Derrick Rossi developed a method for modifying mRNA transfecting it into human cells; dedifferentiating mRNA into stem cells which then differentiated into the desired cell types (to produce specific proteins). Further, use gene-editing technology, CRISPR to disable CCR5 gene to deny a virus enter the cell. Insert synthetic (patent) mRNA into living cells that would reprogram the cells to develop immune responses.

“One specific mutation, the L452R mutation, in the receptor-binding domain of the spike protein may enable the virus to dock more efficiently to cells. Our data shows that this likely the key mutation that makes this variant more infectious.” “In this study, we observed increased severity of disease associated with B.1.427/B.1.429 infection, including increased risk of high oxygen requirement.” Dr. Charles Chiu, UCSF.

COVID-21:

India-Delta Plus- B.1.617.2 variant of SARS-CoV-2 (India, Feb 2021) had become a greater threat with higher severe symptoms, 60% more contagious (susceptible to re-infection by Delta variant) and evading vaccines antibodies (but unlikely to get hospitalized). **Covid-21 – Delta-variant, scientific findings show that the viral load is high.** Reproductive number (R) of 1.44 and prevalence .020%. The Receptor Binding Domain (RBD) allows the virus to use Spike protein to bind to ACE 2 receptor into body. It keeps replicating and mutating with unique physical characteristics and may render vaccines ineffective. Vaccine/ Convalescent sera show reduced neutralization of B.1.617.1 and B.1.617.2, but vaccine based on B.1.1.7 may protect against current variants. Also, monoclonal antibody treatments are ineffective at treating Delta variant. The ‘Black Fungus’ (mucor mucormycosis-serious infection) associated with COVID when cilia-inhale these fungal-spores in your airways and into your lungs or trapped in your mouth and nose. Weak immune system, diabetes and scrape or cut in the skin more likely to develop a black fungal infection. Tissue biopsy, CAT scan or MRI (spread to your brain or other organs). Anti-fungal medications can stop spreading (IV Amphotericin B.); Necrotic case, doctors will surgically remove tissue.

‘MU-variant’ –B.1.621 (Colombia), has a constellation of mutations that indicate potential properties of immune escape. Preliminary data suggests it may be resistant to immunity arising from vaccination like Beta. **‘Variant-of-interest,’** to monitor a virus as it adapts and mutates, has the potential to do more harm. Genomic sequencing has helped experts track and map the evolution of the virus in real time. Genetic changes: P681H mutation –faster transmission; E484K and K417N –evade immunity defenses.

Covid-22: super-strain, more lethal and contagious? SAGE-Group of scientists: ‘realistic-possibility’ that there was a strong possibility of COVID becoming more deadly. Variant-of-concern- ‘AY’-sub-variants in data recently.

Omicron, variant B.1.1.529.

DARPA BIODEFENSE/BIOTERRORISM to fund the development of CRISPR-based diagnostic and bio-surveillance technologies against infectious disease threat. Bio-surveillance efforts intended to enable early threat detection, assess disease severity and countermeasure deployment. **Molecular diagnostics through ‘point-of-need’ tests that can be rapidly programmed for Covid-21.**

Scientists have added silicon-based tracking nano-devices into the interior of cells as a whole to understand the cellular mechanisms, ‘peer-review’?

The effects of inhaled nanoparticles in the body may include lung-inflammation and heart-problems and might be toxic to some types of cells (create free radicals) which can cause cell damage and damage the DNA. Also, in the bloodstream can cross the blood-brain barrier. Lipid nanoparticles (LNP's) drug delivery vehicle, can deliver a toxin (off-switch)? Scientists (2017) reprogram cells' DNA using nanotechnology, can alter DNA, Tissue Nano-Transfection?

Bioelectronic-medicine use injectable or implantable technology for the purpose of treating nerve conditions and monitoring the physiology of the human body from inside. **DARPA-Profusa** (Matt Hepburn) backed by Google (conflict of interest-misinformation), under-the-skin implantable device that allows a person's physiology to be examined long distance via a smartphone connectivity.

IMPACT project-Covid-19 smart vaccine patch through the **use of microneedles (MNs)** will deliver the vaccine and measure inflammatory responses to the vaccination by monitoring biomarkers in the skin (measure its efficacy).

Microneedle-based (MNA) platform for vaccine delivery into the skin containing adjuvant and antigen, probably with **Spike (S) protein** for inducing **cellular immune responses**, sufficient for neutralizing the virus. **Darpa and CRISPR “Gene Drive” (genetic engineering technology)** use the gene-editing tool to copy a mutation on one chromosome and transmitted to offspring (around the rules of heredity). In other words, **alter or silence a specific gene, or insert a new one.** Chinese scientist He Jiankui create the first genome-edited human being using IVF embryos.

“All these technologies, they are dual use. You can use them for good, and you can use them for evil. DARPA is about using them for good to protect our warfighters.” Steven Walker, DARPA.

Genomic Data weaponized reveal population's vulnerability to specific diseases with national security implications; the development of disease pathogens specifically targeted genetic vulnerabilities (population's DNA). Genetic heritage market collects enormous amounts of

data; then, selling the aggregate data of the DNA collected for genealogical research to pharmaceutical companies. China as other countries gather DNA data from other countries. DNA collection future standard part of the biometric data collected by countries from foreign visitors and its citizens.

Clustered Regularly Interspaced Short Palindromic Repeats (CRISPR); gene-editing allows its users to snip a stretch of DNA, and either disable the affected sequence or replace it with a new one, even store data in DNA inside living cells (modify any living organism and permanently altering the human gene pool). Inequality due willingness of such parents to ensure genetic advantage (same with college admissions scandals) over those who are not genetically enhanced. “Decoding human history with ancient DNA;” Liu Jia, Chinese Academy of Sciences.

Ancient DNA (aDNA) obtained from remains of past organisms have shown that archaic and modern humans did not remain isolated from each other; introgression have been found between archaic humans and modern humans. Genetic data support an origin in Africa but difficult to determine a single model for characterizing the origin of African ancestry. Ancient DNA research needs more effort by utilizing other ancient molecular-information such as proteomic, isotopic, microbiomic, and epigenetic-data. Exploring how humans adapted to extreme environments and infectious agents.

“DNA from ancient, unidentified ancestor was passed down to humans living today” by Public Library of Science (plos.org), AUG 2020.

The researchers found evidence that 3% of the Neanderthal-genome came from ancient humans and 1% of the Denisovan-genome came from an unknown. ARGweaver-D (algorithm-computational method) is powerful for detecting ancient-introgression, whenever genetic-exchange overlapped in time and space.

Russian and Swedish scientists tested Neanderthal infant’s DNA (Mitochondrial DNA from baby ribs), “The Neanderthal mt-DNA sequences were substantially different from human mt-DNA.”

“...were not in fact descended from Neanderthals.” NATURE.

“...our results add to the evidence collected...making the hypothesis of a ‘Neanderthal heritage’ very unlikely...” National Geographic.

Anatomically Modern Humans (AMH) fossil record at 200,000 years ago, subspecies Homo sapiens.

“We conclude that the locus cloned in cosmids c8.2 and c29b is the relic of an ancient telomere to telomere fusion and marks the point at which two ancestral eight chromosomes fused to give rise to chromosome number two.” National Academy of Sciences.

Evidence overwhelmingly suggests Homo sapiens are result of forethought intentional fusion with no evolutionary history. Mutation in FOXP2 and Human Chromosome 2 are precise. The advanced intelligence technology that performed genetic modifications giving

200,000 years ago an intelligent form of life. Reluctant to speak publicly about it due losing their credibility or even their jobs.

US Federal Reserve’s monetary policy, in March 2020 launched a quantitative easing program of \$700Bn., then government’s fiscal policy CARES ACT \$2Tn. However, the second fiscal package negotiations between Democrats and Republicans have stalled over the amount of money that could be used to stimulate the US Economy. Both political partisans did not have any disagreement when it was to save the Corporations-Bankruptcy; but, unresponsive and apathetic to the average American citizens due lack of vitality to meet both the base (Corporations-both partisan) and political ideology grassroot (average American citizens). "Additionally, the most frequent answer of the 150 participants who believed there may be a link between conspiracy beliefs and critical thinking ability was classified in the 'no-idea' category...which highlights the difficulty encountered by participants in answering this question..." "...reduce conspiracy beliefs through the enhancement of critical thinking ability...that allow individuals to behave as autonomous and informed citizens." French National Research Agency (ANR) project CONSPIRACY (ANR-17-CE39-0010-01).

Enhance critical thinking, an effective way of reducing the spread of conspiracy theories. Believers (critical-freethinkers) in conspiracy theories glorifying the critical thinking of individuals who subscribe to these narratives ('rational conspiracist-hypothesis' -Prooijen). Van Prooijen -2017: argues that analytical-thinking could be an information-processing-mechanism that mediates the negative association between educational level and belief in conspiracy theories. Research has refined the conditions under which cognitive constructs are related to beliefs in conspiracy theories. Valuing-epistemic-rationality (motivation to form beliefs on rational grounds) and analytic-thinking to distance individuals from conspiracy theories; it is only the interaction between cognitive-skills and valuation-epistemic-rationality relation to conspiracy belief (failure level-of-significance). Critical-thinking construct as high-level thinking skill encompassing rationality, cognitive skills, and analytic thinking understanding belief in conspiracy theories. 'Critical-thinker' –self-identity of someone who master dispositions and abilities, consistent internal motivation to use critical thinking ability in the 'context-of-argumentation.' Critical-thinking ability help individuals to distance from suspect epistemological-beliefs such conspiracy-theories via judgment-of-reliability and credibility-of-sources (the rejection of unsubstantiated claims).

FBI document warns conspiracy theories are a new Domestic Terrorism Threat –extremist.

The Renaissance Party debatable: 'in-the-know and intuition' of the few that results from different narrow-minded perspectives not blindly clinging to those thoughts neither inaction when action is needed (Newton's laws-of-motion). Also, considering other interpretations to evaluate claims and arguments with insufficient-evidence is not poor-reasoning neither does

96. Bruesewitz v. Wyeth LLC, 562 US 223 (2011).

The National Childhood Vaccine Injury Act of 1986 (NCVIA): eliminates a manufacturer's liability for a vaccine 'unavoidable adverse side effects. Products-liability law establishes three grounds: (a) defective manufacture, (b) inadequate directions- warnings, and (c) defective- design. Damages arising from a vaccine-related injury or death associated with the administration of a vaccine. Also, it preempts all design-defect claims against vaccine manufactures.

Section 300aa-22(b)(1): vaccines' design-defect is not open to question in a tort action "by deliberate choice not inadvertence". A vaccine side effect could be avoidable by use of a different vaccine not containing the harmful element.

Design-defects still subject to fraud, intentional and wrongful withholding of information from Federal Regulators or other criminal or illegal activity. Design-defect lawsuits could lead to a recurrence of withdraw of vaccine manufacturers from the market and halt the future production and development of childhood vaccines. To allow a jury in effect to second-guess whether the vaccine caused the injury is to substitute less expert for more proficient experts with field expertise judgement threatening manufacturers with liability and the difficulties to reconcile these potential conflicts.

Again, the "**shock doctrine**" of even-a-brief-period when vaccination programs are disrupted can lead to children's death. Vaccines are effective in preventing outbreaks of disease only if a large percentage of the population is vaccinated. Sensible choice to leave complex epidemiological judgement about vaccine design to the FDA and the National Vaccine Program rather than juries.

A vaccine license spells out the manufacturing method that must be followed, deviations from the license thus provide objective evidence of manufacturing defects and/or inadequate warnings. FDA must make public (transparency) the criteria it uses-to decide whether a vaccine is safe and effective for its intended use which affects individual health. In addition, no more silent on how to evaluate competing vaccine designs and all the elements included in it.

Design-defects allegations are difficult type of products liability claim to litigate. Widespread disagreement exists among public understanding of the childhood vaccine market. Preventable childhood illnesses are ever present in the environment and could create a genuine public health hazard. Since the disease itself invariably leads to a dreadful death; both, the marketing and the use of the vaccine are fully justified (debatable). Who should decide whether a safer vaccine could have been designed?

American-People will not overlook the "innocent-individual" who must bear the risk-of-loss. Despite of possibility of causing vaccine shortages due to "design-defect," tort-litigations' bankrupting-manufactures deprives such vaccine-injured children; **the courthouse doors open a key remedy to those who have suffered severe injuries (someone will need lifelong care) caused from defectively design vaccines.** The immunization policy is meant to save the lives of children considering relevant medical and scientific views. Vaccines manufactures have no legal obligation to improve the designs of vaccines that are already generating significant profit margins. There are thousands of petitions alleging a causal-link between certain vaccines and autism-spectrum-disorders that are currently pending in the Court of Federal Claims (Vaccine Court). The Special Masters (experts) in the autism cases have uniformly rejected the causal link between vaccines and autism. **Those rulings do not**

necessarily mean that no such causal link exists.

US Court of Federal Claims-Office of Special Masters No. 02-0738 V 20 July 2007. Bailey Banks v. Secretary of the Department of Health and Human Services.

The “measles-mumps-rubella” (MMR mercury-laced vaccine preservative-thimerosal) has directly caused a brain inflammation illness called Acute Disseminated Encephalomyelitis (ADEM) that caused the Autism Spectrum Disorder (PDD-NOS) in children. In the Bailey’s ADEM court case was both caused-in-fact and proximately caused by his vaccination; that cause residual damage and retarded his developmental progress (generalized Pervasive Developmental Delay (PDD)).

Bill to open an investigation on mercury link to adverse health.

The 1916 Polio epidemic suspected at the time Simon Flexner at the Rockefeller Institute in New York developed a lethal strain in their laboratory. The fatality rate of 25% was the highest ever recorded for a polio epidemic. **The science, not settled, and fairness concerns are not conspiracy-theorists.** Allegations that DDT created the Polio epidemics and that the polio vaccine (eliminated their natural immunity to polio) injured or permanently paralyzed. Dichlorodiphenyltrichloroethane (DDT) used to limit the spread of insect-borne diseases like malaria and typhus among civilians and troops (WWII) was banned in the USA in 1972. Benzene (carcinogen-toxic-chemical), known in 1948-50 that can cause leukemia and other hematopoietic diseases. For example, the Arsenic drug Tryparsamide used for syphilis is known to cause polio-like paralysis. In spite, the Rockefeller Institute greedy for-profit licensed it despite the warnings.

Moreover, Frederick R. Klenner (MD) had a 100% success rate in treating polio-like symptoms with intravenous vitamin C. The poliovirus infection with a flu-like disease with no paralysis and recovery with no residual effect and others spend the rest of their lives in wheelchairs. DDT-poisoning caused paralysis and enhanced the release of intracellular multiplication of the poliovirus turned harmful. High exposure to DDT as-eating pesticide-laden fruits and vegetables.

“Central nervous system diseases (CNS) such as polio are actually the physiological and symptomatic manifestations of the ongoing government-industry sponsored inundation of the world’s populace with control nervous system poisons.” Dr. Morton S. Biskind.

Xavante-Indian-tribe (untouched by civilization) in Brazil had the antibodies of the poliovirus and no paralysis. The poliovirus existed naturally in human bowels (Neel,1964).

The “natural-immunity” body builds resistance to disease after getting sick and recovering. Vaccine-induced immunity (immunization) interacts with body's immune system to produce a similar response (natural infection) to certain complications (body at risk) that illness will not occur. Vaccines' loss of protection differs from each disease.

People who opposed vaccines (vaccinated as children) do not extend the privilege to their children, and lack of compassion can bring remorse. The polio graph showed that the vaccine eliminated the spread of the disease.

Anti-vaxxers dangerously obfuscate science (mortality vs morbidity) point of view (confirmation bias), "cherry-picking science" (correlation does not mean causation), dangerous conspiracy-theories are the reason for mistrust (widespread-resistance) that threatens health workers and makes it difficult to disseminate vaccines. Conspiracy Theories about the vaccine are a "fairy tale told by a proven charlatan," unwell people, are the answers, you will get to a question and not the peak-of-blindness of health-officials (official-narrative), of authoritarian-citizens. Health Freedom, such a right of bodily-self-possession is nullified by biosafety and biosecurity (new normal).

Equally with Covid-19, the "presumptive-diagnosis" for all patients was C-19 while, in-the poliovirus-epidemic, all patients who experienced paralysis for at least 24 hours were diagnosed with polio. Furthermore, scare tactics (fear and intimidation) and unnecessary therapies were used. The result of vaccine campaign was a disaster, the dangers were hidden from the public officials for fear people would lose trust in their-public-officials. Nurses overworked and frustrated (lot of commotion).

The simian virus number 40 (SV40) an active ingredient in polio and other vaccines causes cancer in humans. Federal agencies did not require vaccines companies to take the SV40 virus out of their vaccines. The government during decades denied such connection between cancer and SV40. **The National Academy of Science Institute Immunization Safety Committee admitted the SV40 is in both the salk and sabine vaccines causes cancer in human.** The rates of childhood cancer continued to rise until it has become a terrible disease that kills children. Toxic chemicals like mercury and aluminum can be dangerous in pure forms, but in vaccines, they are used small amounts as preservatives (toxicity depends on the dose). The body also makes 500 mg of formaldehyde a day for DNA synthesis vs. the vaccine of 0.1 mg. Medical Doctors (MD) do not have total access to the Vaccine Safety Datalink (VSD) epidemiological data for peer-review. In other words, they do not have absolute knowledge of the promoted vaccine adverse side effects neither, are they liable to pass the "risk of loss" to the individual (how convenient). Dept. of Justice with unlimited resources for expert witnesses and other litigation cost clearly favor defendants (vaccine defenders), plaintiffs have no right to discovery either against the pharmaceutical industry or the government. ***The greatest source of epidemiological data is the Vaccine Safety Datalink (VSD) which HHS do not share with independent scientists for peer-review, suppressing real science and research. Therefore, the burden of proving causation is not met ("causal link").***

Bill to publish immediately the Vaccine Safety Datalink (VSD) available to American Society and Scientists, no exception.

Bill to null and void the Office of Special Masters and move the jurisdiction to civil matters giving plaintiffs their “discovery phase” rights.

“With the high efficacy and good safety profile shown for our vaccine, and the pandemic essentially out of control, vaccine introduction is an urgent need.” Kathrin Jansen, Senior Vice-president at Pfizer.

As of November 30th, 2020, COVID-19 has caused more than 60Mn positive cases and claimed the lives of 1.5Mn people worldwide. In the USA, over 13Mn positive cases with +260,000 deaths.

FDA- VRBPAC Briefing Document, Pfizer-BioNTech Covid-19 Vaccine (BNT162b2). SARS-CoV-2 (zoonotic coronavirus) single-stranded RNA virus enveloped. COVID-19 spike glycoprotein (S), which is the main target for neutralizing antibody, binds to the human receptor angiotensin-converting-enzyme 2 (hACE2) to initiate infection. Vaccine’s benefits outweigh its risks of Covid-19, severe respiratory tract disease including pneumonia and acute respiratory distress syndrome (ARDS) leading to multi-organ failure and death; critical to mitigate Covid-19 and prevent future disease outbreaks.

These vaccines are based on different platforms, including mRNA and DNA technologies, includes viral vectored, subunit, inactivated, and live attenuated vaccines (pg. 7). The vaccine (preservative-free) based on the SARS-CoV-2 spike glycoprotein (S) antigen encoded RNA and formulated in lipid nanoparticles (LNP) containing a frozen suspension (-80°C to -60°C) Pg. 8.

Assessments for illness include using a reverse transcription-polymerase chain reaction (RT-PCR) test or nucleic acid amplification-base test (NAAT) to detect COVID-19 (pg. 13). Reports of **lymphadenopathy were imbalanced and notably more cases in the vaccine group (64) vs. the placebo group (6)**, which is plausibly related to vaccination. **Bell-Palsy's cases** were reported by four vaccine participants and none in the placebo group; despite this, there is no clear basis upon which to conclude a causal relationship at this time (pg. 38). A slight numerical imbalance of adverse events potentially representing allergic reactions (**hypersensitivity**) (pg. 40). **Appendicitis** is reported as a serious adverse event (SAE), but there is no clear basis upon which to suspect that this imbalance represents a vaccine-related risk (FDA) (pg. 41). There are no other notable patterns or numerical imbalance between treatment groups for specific categories of non-serious adverse-events (including other neurologic, neuro-inflammatory, and thrombotic events) that would suggest a causal relationship to the BNT162b2 vaccine (pg. 43). Pregnancy, lactation, and pediatric (less than 16 years of age) identified as missing information.

Providers administering the BNT162b2 vaccine must report to Vaccine Adverse Event Reporting System (VAERS) as required by the National Childhood Vaccine Injury Act. An additional source of VAERS reports will be through CDC-V-SAFE (smartphone-based) to

check in with vaccine recipients for health problems following COVID-19 vaccination (pg. 46). Limited data are insufficient to make conclusions about benefit in individuals with prior COVID-19 infection, but it suggests that previously infected individuals can be at risk of reinfection. The data are limited to assess the effect of the vaccine against asymptomatic infection as measured by detection of the virus and/or detection of antibodies against non-vaccine antigens that would indicate an infection, rather than an immuneresponse induced by the vaccine. COVID-19 disease may have long term effects on specific organs associated with sequelae that are either late-onset or undetected at the time of infection. Additional research evaluations will be necessary to assess the side-effects of the vaccine in-preventing long-term-consequences of COVID-19 (pg. 47).

In asymptomatic-cases, a combination of reduced mask-wearing and social distancing could result in significant continued transmission (pg. 48). **There are currently insufficient data to make conclusions about the safety of the vaccine in immunocompromised individuals. The risk of vaccine-enhanced disease over time, potentially associated with waning immunity, remains unknown (pg. 49).**

Full transparency about adverse event reports (potential safety issues) to reassure public trust and carefully weigh the risks and benefits of the vaccine for the Emergency Use Authorization (EUA) granted by the FDA is not the first human experiment neither will be the last. Can be designed and optimized pharmacologically and immunologically for a broad range of applications and re-invent engineered cell therapies.

BioNTech (Germany) self-amplifying on RNA (saRNA) potent activator of the immune

system (immune therapy) encoding the protein of interest and polymerase (replicase) inside the cell, a double-stranded RNA intermediate is generated to be recognized by intracellular immune sensors. Trans-amplifying mRNA (taRNA) replicase can amplify mRNA encoding several different proteins.

Scientists reprogram cells 'DNA cells using a process known as Tissue Nano-Transfection. Biotechnology and Nanotechnology to inject new DNA into the cells (cell reprogramming). Example: skin cells into brain cells. Also, chemical compounds added to genes can regulate their activity (epigenetics).

"If cells are removed from the body, reprogrammed, and then returned, they could be attacked by the immune system." James Lee, PH.D.

Molecular nanotechnology, Nanobots (nano-scale robots interact on the same level as bacteria and virus) inside the human body? Any programming errors? DNA is well-suited to nano-scale construction because of the specific nano-scale structure of the nucleic acid double helix. Are microscopic objects constructed with atomic building blocks of life; auto-replication process to build itself?

In conclusion, this over-exaggerated epidemic to a pandemic-level was to force the US government officials' summit to health official's globalist in the new mRNA and DNA therapeutics-human-experiment needed to advance the next one (WO/2020/060606A1). The design of a vaccine is subject to challenge in a tort action, its intent not to preempt design-defects claims categorically. **The main inquiry is "Could have been designed."** If a plaintiff can show that **an injury in dispute was avoidable through the use of a feasible alternative design for a specific vaccine, then, would have demonstrated that the side effects were not unavoidable.**

Reagan Administration "deep-capture" by the pharmaceutical industry (lobbying-money) leaders advocating for eliminating 'design-defect-liability' and limitations on tort liability or not funding the compensation program at all (misleading because the amount of the tax is specifically included in the vaccine price charged to purchasers).

Cases where plaintiffs challenge the decisions of public-health-authorities and Federal-Regulators that licensed vaccines are to **hold accountable (check and balances) through the Vaccine Act default rule preserving state tort law (civil-discovery not available in the administrative-proceedings).**

Vaccine's side effects are unavoidable and other instances in which they are not, **manufacturer's failure (public health threats) to develop a safer vaccine (could-have-been-designed).** Review vaccines for optimal vaccines design point to "by use of a differently designed vaccine not containing the harmful element;" consider this omission a '**design-defect-liability' beyond reasonable doubt.**

Bill to Null and Void Centers for Disease Control and Prevention (CDC), immediately (No exception).
