Antislavery-principle absent in practice but **declared-so that the enforcement-of-it might follow.** The ‘**democracy-principle;**’ that governments derive their legitimacy from the ‘**consent of the governed.**’***

***James Madison, the principal architect of the Constitution, knew that the threat of tyranny comes from the people themselves in a democratic society (‘tyranny of the majority’). The central purpose of the Constitution was to create a **framework for ‘limited-government’*****

*(authority of the federal-government only in certain-areas) and the rights of the citizens ('Bill-of-Rights') with Representative-government (not democracy) with 'checks and balance' to restrain (mutual-oversight) federal government (tyranny if exceeded their powers).*

**John Adams, "...life, liberty and the pursuit of happiness...;" virtuous-citizenry ability to voted-out-of-office corrupt-politicians, restoring the Republic.**

**Benjamin Franklin: "A republic, if you can keep it." 'Novus-Ordo-Seclorum' (new order for the ages) virtue of self-improvement, make it better.**

**Alexander Hamilton; concept-of-wealth creation – 'capitalism' (innovation, invention, and enterprise), prosperous urban, industrial, commercial society. Network of farming communities –agricultural produce was neglected.**

**"Requiem for the American Dream" by Noam Chomsky (2016):** *The inequality comes from the extreme-wealth of the 'One-Percent' of the general population; with negative consequences on society, corrosive effect on democracy (deliberate concentration of wealth and power).*

**Adam Smith: "Wealth of Nations"-Masters of Mankind; All for ourselves and nothing for anyone else (structures-of-authority). 'Greater-Worker-Insecurity' (job-insecurity keep workers under control) is devastating for society (terms-of-abuse). Working-force precarious-lives, without no way of influencing-policy (dismantling-them); 'free-trade-system' (free-circulation of labor) not in practice. Global-elite engineered: famine (food-rationing), energy collapse, hyperinflation, and medical-tyranny; away from industrial-capitalism and off-shoring.**

**"Capitalism is the legitimate racket of the ruling class." Alphonse Capone.**

**"America's Great Indian Nations –Full Length Documentary," Questar Entertainment – YouTuber (Jun 2013):** *Western-expansion came in search-of-wealth, occupy Native American land and waged war on the American Indians. Benjamin Franklin worked as a British envoy to the American Indians, impressed with the Iroquois' form-of-government. USA treated the entire 'Iroquois-Confederacy' as a conquered nation (surrender their territory), 1830-46 US government broken-treaties, and removal of Indians (force-captivity).*

**Art. 1, Sec. 8 US Const.: "...to promote the progress of science and useful arts, by securing for limited times..."** *The 'patent-protection' for inventors and innovators, accelerated the economic-development of USA but corrupted nowadays (insulin-patent example), technology-usurpation.*

**The "Constitution of the United States of America":** *Country-Charter making it the 'Supreme Law of the Land,' Republic (representative-government). Democratic-principles built into the Constitution but not direct-democracy, to protect the needs and interests of small population states (separate-identity) from densely populated urban-areas. Confederation*

*system of government, the State is supreme and national government powers is granted by the States, a Republic belonging to the people. Correct form-of-government.*

*“This is the fundamental principle of good legislation, which is the art of conducting men to the maximum of happiness and to the minimum of misery...” “Laws are the conditions under which men, naturally independent, unite themselves in society.” “It is better to prevent crimes than to punish them...” “...every act of authority of one man over another, for which there is not an absolute necessity, is tyrannical.” Cesare Beccaria, “Crime and Punishments.”*

The same crimes are punished in a different manner at different times in the same tribunals, every man has his own particular point of view. Beccaria insists that all laws should be able to read and understand the laws by which they live. The classification of crimes is to be measured only by the injury done to society; according to the intention of the person by whom it is committed (natural consequences of the action itself). Crimes of the highest degree are those most destructive of society such as ‘treason’ follow by security of individuals, being the principal end of all society as undoubted right such life and liberty of a citizen.

Universal liberty of action, common to all sensible beings; our minds become free, inspired with that virtue which knows no fear. To control riots, street disorders suggest illumination, guard stations and public meetings in order to prevent it. Social degradation followed ubiquitous espionage, the remedy against them is public disapprobation and ridicule with certainty.

**Let liberty be attended with knowledge, reward virtue, have an educational system which will lead to virtue; no corruption of the blood must be intended not momentary obedience, the punishment should be public, immediate, and necessary proportioned to the crime and determined by the laws not the terror of the ‘spheres of influence’ unseen hand but enlightenment ideas. Beccaria’s original contribution to Criminal Law reform is the rock for subsequent reformers.**

*“Rwanda genocide chemically modified the DNA of victims and victims’ offspring.” Wildman & Mussanabaganwa, USF Innovation/scitechdaily.com (FEB 2022): “Scientists with the USF Genomics program and Center for Global Health and Infections Disease Research...address mental health issues that stemmed from the 1994 genocides of the Tutsi ethnic...Epigenomics...found that the terror of genocide was associated with chemically modifications to the DNA of genocide-exposed women and their offspring...these chemical epigenetic modifications...genocide-related trauma, such as rape or evading capture, witnessing murder or serious attack with a weapon, and seeing dead and mutilated bodies...there’s a lot of PTSD and other mental health disorders in Rwanda...trauma can impact risk for specific mental health disorders...”*

***“Epigenetics refers to stable, but reversible, chemical modification made to DNA that help to control a gene’s function...prenatal genocide exposure was associated with an epigenetic pattern suggestive of reduced gene function in offspring.” Monica Uddin.***

**Victimization** –psychological effects of crimes on the victims. The victims themselves either passively or actively actually initiate the criminal act by exhibits behaviors or characteristics that instigate the attack. Political activists, minority groups, sexual orientation may find themselves as targets of violence. The **‘victim precipitation’** –passive precipitation of violence as result of a power struggle (loss power in society). Threatening the belief and/or ideas of another individual or group of individuals. Example, Hate Crime in which the victim is unaware of the criminal. The active precipitation, behaving provocatively or suggestively (Siegel). Example, Rape Crime when flirtation is present but no consent to sexual intercourse. **‘Lifestyle- choices’**-expose them to criminal offenders that share personality traits like antisocial impulsivity, low self-control, among others put themselves at higher risk. **‘Deviant place’**-dangerous places make an individual more likely to become the victim of crime (Siegel). Social-economic inequality finds minorities from low-income households unable to move away from neighborhood crime-ridden areas, lower risk of victimization is leave for a less deviant area. **‘Routine activity’**-the absence of capable guardians and the present of motivated offenders. Communities-guardianship, alarms and security devices with police protection lower the risks of crime.

Conserve family values, rule of law, private property, and limitations on government explicit principles for the long-term stability and well-being of societies, to guide us in the rebuilding to come such enduring moral order that bind us all. If not dangerous choke between authoritarianism and anarchy, destructive course wreaking-havoc. Unconstrained vision brings educational and moral breakdown rising ‘bad-habits’ to criminal activity. Develop a sense of complete one’s own responsibility for the entire society depends on trust one another (acceptable conduct). Welfare states have no incentive to work, and that dependence pass to the next generation. If an idea is wrong will fail in practice. Constrained vision of our sustenance grounded in Providential God passed the test of time.

As a statement of the fundamental principles of the United States of America (USA), the ‘Declaration-of-Independence’ is an enduring reminder of the country’s commitment to popular government and Equal Rights for all. The government’s officials (a form of government) have become destructive by ignoring that American-People possess inalienable rights that no legitimate government can take away.

**We The People are a constitutional-free-will ideology of law-abiding citizens, conservatives, and moderates with secular-progressive tolerance. Stigma-intimidation (RIGHT-EXTREMISM) weaponized by mainstream media to polarized society (great harm) will not stand.**

**When draconian laws take our FREEDOM, American-People must remember the founding history of the United States of America: The Founding Act of Law establishing sovereignty.** The Declaration of Independence recognizes the right for rebellion, the one action (freedom) that propel sovereignty and bring to life the United States of America Constitution; in spite, never recognized by the USA Supreme Court neither the federal government. Today, this secondary authority must be accomplished through a statement of organization and through the vote to institute a new government deriving their righteous powers from the consent of the governed.

Under absolute Despotism and Tyranny from Federal and State governments, most likely to affect American-People Safety and Happiness, the abuse and usurpation (political dispossession) have altered the Form-of-Government. Political repression with multiple traits of socialism-nationalism (HITLER), communism (STALIN), left and right fascism (MUSSOLINI).

***“Multiple studies predicted governments become authoritarian in response to pandemics” by Derrick Broze/thelastamericanvagabond.com (AUG 2020).***

***“Pathogens and politics: further evidence that parasite prevalence predicts authoritarianism.” Murray, Schaller & Suedfeld (MAY 2013): “According to a ‘parasite-stress-hypothesis,’ authoritarian-governments are more likely to emerge in regions characterized by a high prevalence-of-disease causing-pathogens.” “Results revealed that parasite-prevalence predicted measures of authoritarian governance and did so even when statistically controlling for other threats to human welfare...suggest that societal differences in authoritarian governance result, in part, from cultural differences in individuals’ authoritarian personalities.” “In addition to their intolerance of nonconformity, authoritarian political systems are also characterized by nepotism and ethnocentrism. These behavioral tendencies too have been empirically linked to the threat of disease.” “Authoritarian Governance...governmental restrictions on individuals’ political rights and governmental restrictions on individuals’ civil liberties.” “Wealth inequality...predicts variation in democratic versus authoritarian governance...maximal inequality.” “The key question is whether the relation between pathogen prevalence and authoritarian governance is mediated by individual-level authoritarianism.” “...suggest that the ecological prevalence of infectious diseases predicts the individual authoritarian personalities of people living within that ecological region, and these individual-level dispositions in turn give rise to (and sustain) authoritarian systems of governance.” “...which Ross called “concentration of political power”-a defining feature of authoritarian political systems.” “...predictive effects of threats due to pathogens, famine, malnutrition***

***and warfare on indicators of authoritarian..." "...the perceived threat of infectious disease has effects that are empirically unique and...powerful." "The war-like nature of authoritarian regimes has typically been ascribed to large nation states..."***

Political correctness (mental subjugation) took American society to the slaughter (defeat), no longer redeemable. The watchmen saw the sword coming, the bloodshed on them (responsibility). The 'Global-Elite' grievously mistaken doing business with American society and ownership. The outcome of their intention to act against small business and American Society was and is an Act of War. The 'Federal-Corporation' is null and void because it was never approved by referendum vote; therefore, it was never an "Assent-to-Laws" (consent of the governed). Corporations cannot use the US Pentagon 'deep capture' by Military-Industrial-Complex (biggest corporation on Earth) to impose public policy neither change the form of government.

According to the National Priorities Project at the progressive Institute for Policy Studies, since 9/11, the USA has spent \$21Tn on 'militarization, surveillance, and repression', world's largest exporter of arms, endless wars abroad. The National Defense Authorization Act (NDAA) allows the US President and US Armed Forces to arrest American citizens indefinitely with no courts (due-process) if the government labeled as a terrorist, dissidents (anti-government/extremist or in favor of State or local-authority) as enemies of the State. 'Constitution-free-zone' within one hundred miles inland of the border around the United States, nearly 66% of Americans, unconstitutional and treason. Bureau's Cryptographic and Electronic Analysis Unit (CEAU), investigate public computer networks from 'distressed members of the public.' The militarized Police State –tyranny will certainly be the eradication of the People's Constitutional Rights (back to colonial-era). FBI classified as a 'domestic-terrorism' threat if you espouse conspiracy theories or any view contrary to the government (bureaucrats to retain power at all costs). FEMA-camps includes political-dissidents. Example: 'Main-Core' database; with millions of Americans seen as threats to national-security, to be used by FEMA and the Army in times of national emergency or under martial law (weaponizing-federal agencies for partisan-purposes). The Pentagon's domestic-surveillance on domestic-extremists (policing-activity) is exceeding its constitutional mandate; 'Posse-Comitatus' violation. FBI and DHS need a warrant. DHS – "Rightwing-Extremism" and "Leftwing-Extremism" both reports use the words terrorist and extremist interchangeably. Example, "Operation-Vigilant-Eagle"-surveillance of military veterans as potential domestic-terrorist (psychological effects of war). Government watch

list notice, names of people under 'reasonable-suspicion' of involvement in an extremist group or terrorist activity. The Police-State relying on 'Shadow-Dragon' -surveillance-software in people's social-media and website-activity because everything you do will be wrong or suspect.

*"Consequently, America no longer operates under a system of justice characterized by due process, an assumption of innocence, probable and clear prohibitions on government overreach and police abuse." John W. Whitehead.*

EXAMPLE: Wing of Phoenix, US Babylon; US Sen. GRAHAM (R) & US Sen. BLUMENTAL (D), re-introduced the EARN IT Act (2022). The EARN IT Act: 'Surveillance State' (no encryption); targets every individual internet user by privates' companies to mass-surveillance (scan all user messages, photos, and files). Also, business and homeowner surveillance camera footage sharing with police departments without a warrant. *END OF PRIVACY*. IRS' face recognition to access their website and pay taxes is unconstitutional Surveillance State.

*"DHS/Office of Intelligence and Analysis (I&A): Assessment on Rightwing Extremism (APR 2009)."*

The possibility of restrictions on firearms and military veterans' facing challenges reintegrating into their communities could lead to potential emergence of violent attacks (possess combat skills and experience). Rightwing extremism are hate-oriented (religions, racial or ethnic group), antigovernment (rejecting federal authority in favor of State or Local authority), and single-issue (abortion or immigration). Prominent Themes: perceived government infringement on civil liberties, impending economic collapse, racial conflict, suspension of the US Constitution. Antigovernment conspiracy theories (domestic extremist individuals) and end-times prophecies (Christian Identity). Illegal immigration taking away American jobs through their willingness to work for lower wages, and lack of government action on illegal immigration. US Government's role as either complicit in a foreign invasion or acquiescing as part of a One-World-Government. China's investment in US real-estate and corporations as a part of subversion strategy. Disgruntled military veterans' skills and knowledge have the potential to boost the capabilities of extremist (Operation Vigilant Eagle). Lone wolves pose the most significant domestic terrorist threat because of their low profile and autonomy. New technologies permit domestic extremist to send and receive encrypted communications. New legislation banning paramilitary training, and militia frustration that the 'revolution' never materialized. Federal, State, and Local emphasis on the political, economic, and social factors that drive rightwing extremist radicalization, concerning suspicious or criminal. DHS National Operations Center



(NOC)/Fusion.

UN Counter Terrorism Executive Directorate (CTED): establish ‘Great Narrative’ taking control of information, and Domain internet censorship (offline). People surrender their rights and freedom, by media and governments DECEPTION AND BRIBERY. Technocratic Authoritarianism: to legitimize their power as universal truth and suppress all objections.

EXECUTIVE ORDER: Federal questions: Petition Redress of Grievances (USA Const. First Amend.), Saccharine Terrorism? Obstruction of Justice (18 USC Sec1503)?

MIT’s computer confirmed 2040 world collapse?

Stagflation: trade deficits and budget deficits; hyperinflation, impoverish an entire generation. Self-destructing because debt creation, not productivity. Trump’s DHS created dossiers on American citizens in Portland over summer of 2020. Biden administration open-borders’ is national security threat, but Ukraine’s border is priority, including nuclear-war with Russia. Russian warships on coast of the United States, and strategic/fighter aircraft near US airspace (2021). The mechanisms that act to detach groups of people from social-mainstream (censorship expressing political views), dispossession through digital-punishment. We are living in a digital-age, putting people at risk of being excluded from participating in the social, economic, political, or cultural activities essential to social-inclusion. Internet use can have harmful consequences as internet addiction disorder, deterioration or loss of interpersonal

relationships, propensity to narcissistic, threats to personal privacy, cyberbullying, among others.

A victim of sex abuse (case 3:21-cv-00485) sued **Twitter, the complaint about benefiting from a sex trafficking venture in violation of the Trafficking Victims Protection Act (18 USC)**. Refused to remove graphic images of sex abuse (sex traffickers) after reviewed the content and did not find child sexual exploitation policy violation but monetized through distribution. **Technocrats will regulate the internet (censorship) as a “dangerous tool” in need of official oversight to curtail such “illiberal voices.”** Internet censorship (control or suppression of what can be accessed or published) based on cyber-sovereignty.

**US Air Force’s Research Lab**-State surveillance track citizen’s behavior as mechanism of control. **Ultrasonic cross-device tracking** linking multiple devices with audio-beacons, microphones, and gyroscope sensors. **Police use “stingray tech”**—phone-based surveillance to identify protesters.



Culture of self-censorship mandates that companies be responsible for their public content. USA government-private partnership (bloc of dictators) model standards, the 1st Amendment protects the freedom of speech and expression against government censorship (silencing dissent). Online communities should be allowed to self-regulate according to their members' free from government surveillance or corporate influence.

**Representative Ocasio-Cortez calling for a Commission on “media-literacy”** (deprogram conspiracy theorists), silencing dissent against progressive leftist dogma (socialist-supremacy) guise on disinformation or misinformation. The New York- Westchester High School banned the Luke Wong Pro-Freedom student club requiring intervention from Alliance Defending Freedom. Moreover, liberal activists, calling for deprogramming-Veterans from disinformation. The live dispute over citizens (incompliance) or subjects (compliance) due to Democrats total control over American society.

Examples: FBI COINTELPRO (1956-1971) and Soviet Union legal policy of repression of political opposition (penal code).

**American-People constraints (repressive-activity) suppresses dissident mobilization reducing the capacity of organization from their overtly or covertly behavioral threat. The “Law of Coercive Responsiveness” (Davenport, 2007) explain when challenges to the ‘status-quo’ take place authorities employ repressive action to counter or eliminate the behavioral threat (displace current political leaders-economic system).**

Example: Philadelphia-woman raped on train in the presence of Septa-riders' not-intervening neither called 911. The victim's 8 minutes of horror on a commuter-train happens as result the criminal incapable of higher-level processes as self-control; and bystanders' lack-of-civility, antisocial-behavior, and dehumanization (deprive human-dignity). McDonald documented the persecution of the Jews in Germany. Relentlessly the Jews are excluded from all public offices, from the exercise of professions, from any part in the cultural

and intellectual life of Germany. Increasingly difficult for Jews to sustain life, no field of economic activity. The conception of the “absolute subordination of the individual to the State.” William Safire notes that the term ‘racism’ was originally used to describe policies defining and directed against Jews as a race, but the impetus for this dramatic increase in usage did not come from within the English-speaking world, or Germany but from Italy. The Italian Fascist dictator Benito Mussolini had opposed NAZI racism but also took political, economic, or moral measures against Jews (hostile to the regime). The Republican Party is a legit political ideology as it is the Democratic Party. ***Bill A416 Sec 2120.a: Removal and detention of cases, contacts and carriers who are or may be a danger to public health (state of health emergency due to an epidemic of any communicable disease) including suspected cases, contact or carrier of a contagious disease by issuing a single order. Such person or group of persons shall be detained in a medical facility or other appropriate facility or premises until no longer presents a potential danger to the health of others (no longer is or will become contagious). To be detained in a manner that is consistent with recognized isolation and infection control principles.***

- The governor shall make an application for a court order expedited hearing; in no event shall any person be detained for more than sixty days without a court order authorizing such detention.
- The governor shall seek (other law or regulation) further court review of such detention within ninety days following the initial court order authorizing detention and thereafter within ninety days of each subsequent court review.
- Review of the continued detention of a person or group shall prove the particularized circumstances constituting the necessity for such detention.
- A copy of any detention order shall be given to each detained individual, when impractical to provide it may be posted in a conspicuous place in the detention premises.

- **Description of the circumstances and/or behavior of the detained person or group constituting the basis for the issuance of the order. Notice advising the person or group being detained have a right to:**
  - request release from detention,
  - to be represented by legal counsel (extent feasible),
  - relative to receive notification of the person's detention,
  - forcible administration of any medication without prior court order.
- **Shall not conduct himself or herself in a disorderly manner and shall not attempt to leave such facility or premises until they are discharged.**
- **To require the testing or medical examination of persons who may have been exposed or contaminated with dangerous amounts of radioactive materials or toxic chemicals to complete prescribed course of treatment, preventive medication, or vaccination.**

**Warning "Queue," Warning: "Bill A416" Warning "Detention Centers".**

**Bill A352 Prohibit the purchase or possession of a body vest.**

New York would make it illegal for civilians to purchase body armor, **the most passive form of self-protection** against gun violence. NY State denied civilians body protection from different weapons, situations, and threat levels. The NY State public policy reflect tyrannical agenda towards the average American citizens. If a government makes a person more vulnerable to danger, then a Section 1983 lawsuit against the state may be appropriate if the constitutional rights of the people were violated.

Civil Action No 2:29-cv-677 County of Butler v. Thomas W. Wolf:

Violation of the right of assembly-First Amendment, Substantive Due Process and Equal Protection-Fourteenth Amendment (state police powers in reacting to emergency situations relating to public health and safety). Pennsylvania Stay-at-home and Business Closure orders are unconstitutional.

*Jacobson v. Massachusetts (197 US 11): “... that the police power of a state, whether exercised directly by the legislature, or by a local body acting under its authority, maybe exerted in such circumstances, or by regulations so arbitrary and oppressive in particular cases, as to justify the interference of the courts to prevent wrong and oppression.”*

Involuntarily “stay at home” orders (confinement at home-limited by law) never been used to combat any other disease, exceeded legitimate government need and authority. Quarantine requires a sick person not an asymptomatic person with a period of time equal to incubation period of the disease not long term and open-ended. Citizen right to be out and about in public in a lawful manner is an integral component of life in a free and ordered society.

When an executive order is “suspended” not rescinded the “voluntary cessation doctrine” do not apply because the wrongful behavior it could be reinstated. The “new normal” of disease mitigation restrictions “in effect until further notice” (extraordinary unilateral power).

**Freedom, an expression of law so fundamental that has precedence even over the USA Constitution (adopted in a period of grave emergency) granted by the Declaration of Independence.** Scholars of constitutionalism prohibits amendments or laws that threaten human rights; furthers the necessity for judicial review for balanced federal government failure to do so constitute a dereliction of duty.

Michigan's Supreme Court ruled against Gov. Whitmer emergency powers (via executive orders).

***"We conclude that the Governor lacked the authority to declare a 'State of Emergency' or a 'State of Disaster' under EMA after April 30<sup>th</sup>, 2020, on the basis of the Covid-19 pandemic. Furthermore, we conclude that the EPGA is in violation of the Constitution of our state because it purports to delegate to the executive branch the legislative powers of state government-including its plenary police powers-and to allow the exercise of such powers indefinitely." Justice Stephen J. Markman.***

***"...will continue under alternative sources of authority that were not at issue in today's ruling." Gov. Gretchen Whitmer (2020).***

This extraordinary unilateral powers without government check and balances are tyranny. The general principle of effectiveness requires that the rights of individuals inherent to the government that ensure the full effect of rights and obligations. Therefore, a State must be liable for loss and damage caused to citizens (obtaining redress of grievances). State liability to individual as a result to transpose directives cause loss and damage. State liability for damages to individuals injured by a failure to transpose directives.

#### **Civil No. 3: 20-cv-00036-GFVT Ramsek v. Andrew Beshear.**

When it comes to restrictions on our liberty, courts must not accept as sufficient whatever explanation is offered. Even in time of crisis, the Constitution puts on government actions.

**Prohibition on gathering in large groups to express constitutionally protected speech is unconstitutional.**

Plaintiffs express their views through protesting Governor of Kentucky response to Covid-19 (assessment of risks and how to best minimize the risks of spreading the virus). CDC defines "mass gathering" as a group of more than two-hundred and fifty (250) people. There are no limits on the number of people who can attend outdoors activities as long as they keep six feet apart and adhere to the regulations.

Pentecostal Church v. Newsom, US Supreme Court Chief Justice Roberts issued a concurring opinion expounding on the reasons for denial. Plaintiffs disagree, arguing that Judge Robert's opinion "does not create any precedent, much less binding precedent." Justice Roberts concluding that "the notion that it is indisputably clear that the [California] limitations are

unconstitutional seems improbable.” In other words, was not “indisputably clear” California law violated the Free Exercise Clause; his conclusion does not create precedent.

**This is so, because it is not just the speaking, chants and signs that are expressive; it is also, the message implicit in the size of a crowd (371 US 415).**

**The very idea of a government implies a right on the part of its citizens to meet peaceably for consultation in respect to public affairs (92 US 542).**

The First Amendment does not regulate government speech; therefore, not subject to scrutiny. A regulation is “narrowly tailored” if it promotes the significant government interest without unnecessarily abridging speech; but it is the right to protest through the freedom of speech and freedom of assembly clauses that is constitutionally protected.

US District Court, Northern District of Illinois Judge Robert W. Gettleman *Beloved Church v. Pritzker* Case: 3:20-cv-50153; Violation of the First Amendment’s Free Exercise clause EO 2020-10 prohibits “all public and private gatherings of any number of people outside a single household.” The plaintiffs alleged the governor discriminated against people of faith by prohibiting religious services. The plaintiffs appealed to the Seventh Circuit No.20-1757. In *Pentecostal Church v. Pritzker* 962 F.3<sup>rd</sup> 341 (7<sup>th</sup> Cir. 2020) concluded the district court’s decision should be affirmed. “Illinois has not discriminated against religion so has not violated the First Amendment.”

**The USA Supreme Court in the name of protecting the health of its citizens fails their duty to uphold the USA Constitution, American-People devolving into subjects. “The precise question of when restrictions on particular social activities should be lifted during the pandemic is a dynamic and fast intensive matter subject to reasonable disagreement.” “...right to practice religion freely does not include liberty to expose the community...to communicable disease.” Airborne transmission of Covid-19 can overcome physical-distancing and cleaning measures. The neutrality requirement means that a law must not “infringe upon or restrict practices because of their religious motivation.” (Lukumi).**

**US Dept. of Justice (April 2020), William P. Barr: Issues Statement on Religious Practice and Social Distancing urging that religious gathering be treated like gatherings at movie, theaters, restaurants, and concert halls. Maintenance of the neutral and non-arbitrary cover of the rule of law.**

**The Renaissance Party concurs with the plaintiffs *Pentecostal Church* case was wrongly decided. Also, respectfully dissent on *Pentecostal Church v. Newson*, 140 S. ct. 1613 (2020) in which the USA Supreme Court rejected an application for an emergency injunction against California restrictions on religious services. This case should have use lens of “strict scrutiny,” to evaluate the constitutionality of governmental discrimination, instead**

deferential standard.

One of the functions of courts are to identify (cultural functions), never coerce cultural practices (livelihoods) to determine whether a particular action will resolve legal rights, the nature of the issues involved, and the remedy sought. The “essence of the act of judging” embrace those fundamental rights which belong to the citizens of all free governments, the system of check and balance protecting those liberties. The essential characteristic, the granting of rights to the citizens which posits existence within them cannot permit a substantial intrusion (shock the conscience) into their autonomy (freedom). The contextualism (balancing test) and functionalism (determine the character of a function) to consider the strength of governmental interest in test of Constitutional issues. Balancing judgements in determining how far the needs of the state can intrude upon citizen’s liberties and privacy vs. legitimate governmental interest.

Reducing the rate of transmission would not be much use if it creates more chaos and this is not a second guessing. Indeed, American society have a Constitutional crisis: biosecurity public policy. The health authorities just got unilateral powers in their medical tyranny approved by judicial review. USA Supreme Court brought destruction to American Society when now the enemy knows that all it takes is a virus to take down USA powerhouse. American society confront a future of biological warfare. USA loss two battles already, One World Government “coup d’état” (Global Financial System) and Biosecurity Public Policy (Covid-19). The voters are too complacent to change the government (status-quo) urgent need (USA is “deep capture”). Jacobson v. Massachusetts 197 US 11 (1905)-US Supreme Court Case in which the court upheld the authority of states to enforce compulsory vaccination and revaccination laws; but States are not required (obligated). Legal issue of vaccines under the police power of states. Personal liberties might be suspended in the interest of the “common good.” The defendant alleged injuries or dangerous effects of vaccinations.

***“Each of them, in its nature, is such that it cannot be stated as a truth, otherwise than as a matter of opinion” Justice Harlan opinion of the Court.***

At the time there was no knowledge of the “so called Facts,” but today, we do. Look at: **Vaccine Injury Table (NCVIA)** describes adverse side effects of each vaccine. The case recognize that a vaccine requirement could be unduly harmful for some individuals (immune disorder or cancer are medical exemption). Federal authority on vaccines applies to situations of national concern such quarantine of foreign disease and regulation between States. **It needs to have “general consensus” among scientists and medical health experts.** Today with Covid-19, the doctors with dissenting voice are under censorship authorized by the National Security Advisor of the United States. Even active Doctor of Medicine with

different medical treatment protocols are being censored, denying science results from such Covid-19 patients' recovery to understand this novel virus.

Trump's administration vaccine CZAR conflict of interest, Moncef Slaoui-former GlaxoSmithKline executive will lead the development of a vaccine for Covid-19 (**Operation Warp Speed**). **Covid-19 vaccine, lack of time and opportunity for sufficient medical experience, there can be no assurance of safety or even purity of Ingredients.** Undertaken to supply the public, the situation calls for strict liability when its dangers can be eliminated through design changes scientifically knowable at the time it was distributed (tentative Winter 2020).

**Bill to Amend the U.S.A. The Insurrection Act of 1807 (invoked twenty-two times) gives the USA President the ability to deploy active-duty troops as a Police Force when authorities of the "State or Possession" are incapable of maintaining public order (rule of law) and deprived of a right or protection of its people. The "Proclamation to Disperse" by the USA President to (use the armed Forces) immediately order the insurgents to retire peaceably within a limited time.

President Trump ("King of Babylon") confusion with **National Emergencies (50 USC Ch34)** and the **USA Constitution**, thinking that one individual can **exercise power without any legal restraint**, for a long-term period **is dead wrong**. Also, "**dictatorship**" as an emergency measure could be held for six months until government "**balance of powers**" terminated the emergency (Congress) or declared unconstitutional (**USA Supreme Court**).

**"Executive Orders"** directives from the US President cannot supersede the USA Constitution "Bill of Rights." The **USA Supreme Court is responsible to declare it unconstitutional**; even if, USA Congress passes a new law to override it, still subject to a presidential veto.

**Declassification and Disclosure** of past and present executive orders **will expose unconstitutional expanded powers**. There is no justification to override the "balance of power" of the USA Constitution, NONE.

**Bill to amend USA Const. Art 2 sec 1; "Ex-presidents would not have access to intelligence briefings neither classified information." No exception.**

President Biden put the USA “power grid” in danger from foreign adversaries when suspends for 90 days EO- “Securing the US Bulk-Power System” (undue risk of sabotage). On the States Government versus Federal Government issue, the USA Constitution granted US Government its powers, and the **10<sup>th</sup> Amendment handed powers over to the States**. The “**Anti-Commandeering Doctrine**” gives “**States Autonomy**” on issues under **their discretion**; nevertheless, no need to adopt or enforce the federal law: **Murphy v. NCAA (2018)**; **United States v. Morrison (2000)**. Furthermore, **Emergency Powers of Governors Act of 1945 (EPGA)** gives them authority to declare and extend the state of emergency. **Emergency Management Act of 1976 (EMA)** gives governors the authority to declare state of emergency for 28 days; thereafter, the State Legislature can approve an extension.

The “**State Action**” doctrine applies only to the government (not private conduct) emphasis on protections of individual liberties and the evolution of equal protection on shifts in the cultural and political climate. The circumstances under which rights and liberties can be regulated by a “State Actor” need examination. Besides, the “State” nullifying federal unconstitutional laws or regulations place “on-notice” exceeded their authority. Moreover, if other States nullify the law, or regulation, they will be powerless to enforce it.

Texas, Collin County District Judge, Hon. Andrea Thompson ordered US Citizen Mariam Ayad (political dispossession) to undergo Islamic Court-High Panel (due Islamic prenuptial agreement) to decide her divorce under Sharia Law (pronouncement of Talaq, initiate a process when completed the divorce takes places). Chicago, New Orleans, and Los Angeles among others, used it. “**Technical Flaws**” of this policing software (**Palantir Technologies-CIA**) **override the legal principle of presumption of innocence** (V and XIV Amendments).

**Bill to open an investigation on Palantir Technologies.**



**Bill to open an investigation on NSA's PRISM (Mass Surveillance).**

**Bill to open an investigation on Top-Secret National Security government database "Main Core" used to keep track of dissident American citizens without a warrant with no connection to terrorism. Political espionage (political adversaries) in violation of the First Amendment such as "Insider Threats."**

**Bill to open an investigation on National Counterterrorism Center (NCTC).**

The **National Security Commission on Artificial Intelligence** (Eric Schmidt) race to develop the greatest AI algorithm (harvest data from American citizens) to maintain the US economy and military hegemony. Silicon Valley-tech leader and US military- competitive over China. In other words, a total remaking of American society's livelihoods through distractions (not paying attention behind the scenes) that consume media-time and energy. Digital footprints from online activity (anything on the Internet with your name on it). Affect-recognition-systems can detect a person's emotional state? Intelligence community policies and stigmas posed a corrosion of individual's inalienable rights. Examples: suspicion of centralized Federal authority, anti-global, reverent of individual liberty, exhibiting a belief in conspiracy theories that way of life is under attack. Google-Dragonfly project, censor web-content and monitor citizens' behavior-online, rebranded?

The **Office Biometric Identity Management (DHS)** begins moving the nation's biometric data on US citizens and foreign nationals to Amazon-Gov-Cloud. Homeland Advanced Recognition Technology (HART) will be the system of record for national security biometric data when the cloud migration is completed. DHS biometrics collection of iris scans, palm prints, and voiceprints regardless of age.

Clearview AI (facial recognition app) helped match photos of unknown people to their online images goes beyond anything constructed by US Government or Silicon Valley.

**ACLU v. Clearview-AI, Case No. 20CH4353, Calendar 11.**

Clearview-AI violates the Illinois' Biometric Information Privacy Act (BIPA), requiring corporations to get written 'opt-in-consent' from a person before collecting their face-print. Biometric-identifiers (biologically unique to the individual) include a 'scan-of-face-geometry.' **The court entitled to 'intermediate-scrutiny' to protect public 'privacy and security' from biometric-surveillance.**

**Bill to Enact "Criminal Liability of Excessive Force" (4<sup>th</sup> Amendment, Referendum Vote) to void USA Supreme Court Legal Doctrine "Qualified Immunity". This doctrine has shield government employees accused of using excessive force (violation of the Fourth Amendment); it promotes police brutality and denies victims their constitutional rights (people treated unjustly). Excessive force will be separated from "clearly established" (loophole), egregious acts of police violence (chokehold and Ban-Hogtie) on unarmed citizens. High risk jobs with the split-second decisions need to be achieved without harm to others, enforcing the law in good faith. Government employees will be held liable for**

**“excessive force” (prosecuted not disciplined).**

The four Minneapolis officers (May-2020) watched while one knelt on the neck of George Floyd (handcuffed and pinned to the ground) kept up pressure on his neck ignoring Mr. Floyd who expresses repeatedly over and over he cannot breathe until causing his death. The formal accusation of the arresting officer for criminal negligence and involuntary manslaughter is unquestionable. When Mr. Floyd becomes silent and motionless (more than 8 minutes), and bystanders begged the officer to stop; at this point, “excessive force” was clear (violation of the 4<sup>th</sup> Amendment). The doctrine “Qualified Immunity” does not apply because the “clearly-established” clause had violated a Constitutional Right beyond a reasonable doubt. As well, the other three officers must be charged with criminal negligence. “Excited Delirium” controversy among medical examiners and emergency physicians in regards if it is a medical condition. Disproportionately cited in cases where Black and Hispanic men died in custody. BLUE BLOOD IS HONOR and these officers (bad policing) disgrace the BADGE- PRECINCT. Minneapolis Police Department Chief should resign because the relationship between the police and the community under his watch, has been fractured. George Floyd mural in Toledo, Ohio destroyed by lightning strike collapsing into rubble. There are no synchronicities. It repeats, another victim, but the same police brutality, as it also happened to Eric Garder. Videos show NYPD officers used “excessive force” (knelt on the neck and physical aggression) on unarmed citizens during the lockdown and knew they were breaking “clearly established law.” Therefore, NYPD actions are unlawful, the omission for conflict resolution and to de-escalate was present. NYPD Police Commissioner Dermot Shea’s resignation is unquestionable. Was **NY DA’s Office**, not holding criminals accountable during Manhattan riots? How many cases? How many millions of dollars the Insurance Companies pay in claims? Peaceful? Backlog of cases created by the district attorneys’ offices and the courts prolonged closure during Covid-19 result without accountability in most cases and not justice to the victims (citizens and business owner).

**Bill to fire every police officer with “excessive force” and “no probable cause” complaints (two) and seven complaints regardless of the issue. Also, police drawing the service weapon in the absence of legitimate danger and threat. “Wanton-endangerment” consciously disregards a substantial and unjustifiable risk. Breonna Taylor case exposed the “No-Knock-Warrant” (unconstitutional).**

**Bill to enact, create and fund database on civilians killed or seriously injured by police countrywide.**

**Bill to open investigation (forensic accounting) into destroy and looter business if there is any correlation on the acquisition of insurance policy prior one month before riots civil unrest.**

Malfeasance? US government unlimited resources versus political organizations may include illegal "After-the-Facts" investigations guise under terrorism and the court has to issue the order. The USA PATRIOT Act single jurisdiction "Search Warrants" within or outside the district that would be difficult or impossible task for any average American citizen. Taxpayer information also could be used by law enforcement to gain access to confidential information of political dissidents deemed a threat. Obama Administration- IRS (2013) alleged weaponized (abuse of authority) against Tea Party (tax-exempt status) but mainstream media did not report the legal cases filed that have been settled. In the other hand, Treasury Inspector General for Tax Administration (TIGTA) issued a report that it never happened. The IRS did use politically oriented search terms to try to sort through applicants for inappropriate levels of political activity, not ideology. In laser technologies look at the “ZKZM assault rifle,” causes instant carbonization of human tissue, properties of the laser beam (invisible to the naked eye) used in covert operations.

Society faces many uncertainties (helpless) one of them is **Extinction-Level Event (ELE)** triggered by an asteroid or comet moving towards Earth. If the trajectory ends up on a collision course with Earth could extinguish most life or wipe out civilization. Satellite collisions would produce orbiting fragments increasing the probability of further collisions, leading to Earth-orbiting belt within this century. The Space exploration need intervention because the Earth is not a junkyard.

RADIATION-INTELLIGENCE: information from unintentionally emanated electromagnetic waves in the environment. NSA's electronic equipment analyzes electrical activity in humans from a distance for national security purposes. RNM can map-out electrical activity from the visual-cortex of a subject's brain and show images from the subject's brain on a video-monitor, NSA-operatives see what the surveillance subject's eyes are seeing. Also, while in R.E.M. sleep, for brain-programming. This is all done with no physical contact with the subject. RNM can alter a subject's perceptions, moods, and motor-control. RNM: audio-visual brain-to-computer link, monitoring bioelectric information in human brain without regard for human or constitutional rights. NSA' SigInt can remotely detect, identify, and**

monitor a person's bioelectric fields. EMF brain-mapping program; each person's brain has a unique set of bioelectric resonance/entrainment frequencies. Speech cortex/auditory cortex link has become the ultimate communications system for the intelligence community.

Extra Low Frequencies (ELF) radio-signals can pinpoint a target anywhere on Earth, and penetrate dense-matter, delivered via satellite. Neuro-Sky: ECG-chip, tracking biometrics. Brainwaves trigger changes in the Hologram. The 'Neural-Lace' minimally invasive three-dimensional mesh nano-electronics, via syringe-injection, into living brain tissue to allow neuronal-networks. Types of neural-nano-robots: endoneurobots, gliabots, and synaptobots.
